Subject: - Completion of course content in various skills allotted to schools under CSS-VSHSE.

Dear Principals.

As per standing instructions communicated vide memo no. 1/1-2012 dated 4.10.2016 (copy enclosed), the Principals in the absence of Vocational Teachers in the relevant skill are empowered to make stop gap arrangement for covering the course content in skill taken up by the students under CSS-VSHSE.

The recruitment process to fill up the various positions of Vocational Teachers is on and will take some time.

It is therefore reiterated that in the new schools covered from 2017-18 and in the 990 schools where skills introduced in earlier years, and the Vocational Teachers are not in position, the Principals are requested to make following interim arrangement immediately:-

- (i) As a first step it should be ensured that where possible the regular faculty can fill up the gap- For instance generic content in skills such as Retail, Financial Services Banking, Insurace can be taught by PGT (commerce), PCA by PGT (Physics, Chemistry, Biology), Physical Education and Sports by PGT (Physical Education & Sports).
- (ii) After exhausting option (i) the coverage of syllabus be done through guest/extension lectures as per honarium mentioned in letter no. 1/1-2012 dated 04.10.2016, till Vocational Teacher on contractual package is positioned. This is to be done locally through qualified persons as per prescribed qualifications (copy enclosed).

Please ensure compliance accordingly.



Guidelines for incurring expenditure under NSQF compliant CSS-VSHSE.

Please refer to the subject cited above.

Matter regarding revision/modifications in guidelines for incurring expenditure under various components in view of scheme revised by MHRD, Govt. of India has been under active consideration. Now the following guidelines in supersession of earlier guidelines are issued:-

1. Flexible Pool:-

- A) Expenditure for the following objectives can be incurred under this component:-
 - Salary of Vocational Teachers, Industry Coordinators, District Coordinators.
 - ii) Engaging Skill Knowledge/Vocational Training Providers
 - iii) Payment to Guest Faculty/Resource Persons
- B) Guest Lecture from concerned Industry Expert/Resource Person Guest lectures are essential and integral part for the transaction of course curriculum. One of the prerequisites for the success of the scheme is participation of Industry and Employers. Further, under the scheme the emphasis is on overall development of skills of the students. Therefore, one Guest lecture is to be organized for each level (L-I, II, III & IV) per month by inviting concerned Industry expert/ Resource Person and to be paid an honorarium @ 500/- inclusive of all per hour for maximum duration of 2 hours. There can also be interaction with other community leaders from various professions like Civil Services, Doctors, Health Workers, Engineers, Progressive Farmers, etc. who may come to the school and speak to the students about their profession and how the youth can make a difference to the country by joining that profession. Guest Lecture will be approved by concerned school Principal and it will be the duty of School Principal/Vocational Teacher to have a close liaison with Industry experts and invite them for Guest Lecture. The VTP in the skill concerned will also have a liaison with the Industry and facilitate the process. Proper record of the expert invited, payment made, topics covered have to be maintained by the Principal and expenditure is to be reflected accordingly in the monthly expenditure statement.
- C) In case of non-availability of Vocational Teacher deployed by VTP/Department due to any reason, Principal is required to cover the course content by organizing extension Lecturer on day to day basis, as a stop gap arrangement and the honorarium @ Rs 500/- for two lectures per skill per class per day and for the whole month for class or classes/periods/hours put together should not exceed Rs 10,000/-. Proper record of the expert invited, payment made, topics covered have to be maintained by the Principal and expenditure is to be reflected accordingly in the monthly expenditure statement.

- D) Similar action as mentioned under Serial No. B above be taken in case of Vocational Teacher appointed by Department proceeds on Maternity Leave.
- E) In case of teacher appointed by VTP proceeds on maternity leave, VTP concerned will provide substitute and salary will be claimed by the VTP as per Maternity Benefit Act but in such a situation management charges will be restricted to one teacher only. In other words deployment of substitute/payment of salary is to be taken care by the VTP. Any delay/ default on this count should be immediately reported to the Parishad.

2. Raw Material:-

Expenditure on account of procurement of Raw Material & maintenance of tools & equipment, purchase of books, software, e-learning material, etc. can be incurred under this component only after obtaining specific administrative/financial approval from Parishad. List of raw material for various skills is shared with the Principals from time to time. Procedure/guidelines as shared with the field functionaries are to be followed. A copy of letter no. 10/26-2011- ADMN (4) dated 01.08.2011 and Finance Department notification no. 2/1(4)-87-4FR dated 12/03/2006 is enclosed for ready reference.

3. Hands on Skill Training to Students:-

Expenditure on account of providing hands on skill training to students in industrial and commercial establishment can be incurred under this component:-

- A) Industry Visits are essential and integral part for the transaction of course curriculum. Further, under the scheme the emphasis is on overall development of skills of the students and they are required to undergo practical training in a designed fashion. Industry Visits and Practical Training will be approved by concerned school Principal and it will be the duty of School Principal/Vocational Teacher to have a close liaison with Industry and prepare proposal for such a visit/Practical Training keeping in view following parameters:-
 - Number of Industry Visit & Practical Training to be conducted in an academic session:-

- ii) The students may be sent to a local industry for a visit where the various aspects of the industry and the skills required to run/work in the industry would be explained to the students.
- iii) In the first place Govt. transport is to be hired. In case of non-availability, the school head will take three quotations from private registered operators and

would match it with the Govt. transport rate. It should in no case be higher than the Govt. Transport rate and the lowest quoted rates be processed.

- iv) Each proposal for such visit/practical training should include financial implications and date of visit/ practical training with place/places to be visited. The financial implications should include hiring of transport, viz-a-viz the funds available under this component.
- v) Proper bills/vouchers, attendance record has to be maintained about the industry visit/practical training.
- vi) The Industry visit/practical training should be planned according to the syllabus and the lesson plans by the teacher so that the students can relate their learning's with the ground realities.
- vii) Vocational Teacher must visit the Organization prior to the actual visit of the students.
- viii) School Principal along with the Vocational Teacher must inform about the Industry visit/practical training a week in advance to the students and discuss in detail the purpose and the place of visit so that the parents of the students be informed in advance and be taken into confidence, consent obtained in writing by laying emphasis that such visits are essential part of course and are to the benefit of their children. Safety of the students is the personal responsibility of Vocational Teacher/School Principal. In Case of Girl students, a female teacher from the school should accompany the students during the time of visit.
- ix) School Principals are advised to take the students during the non-peak business/study hours and also take care of School time table. It is also to be ensured that the staff at the organization to be visited spends time with the students.
- x) Attendance signed & stamped by the Organization where Practical Training is planned is to be taken. Since Practical Training carries no value if we do not provide Practical Training certificate to the students, it will have to be ensured that the Organization does issue an individual/clubbed certificate to the students who have undergone Practical Training.


4. Cost of Assessment & Certification:-

The State Board would conduct external competency based assessment of skills of the students in collaboration with the concerned Sector Skill Council/NSDC.

Since the assessment is done by SSCs and Board of School Education, Haryana, no action in regard to payment of assessment fee is required to be taken at school level. School heads are to facilitate conduct of assessment in coordination with the Board of School Education, Haryana.

5. Machinery & Equipment:-

Expenditure on account of procurement of Machinery & Equipment, furniture, computers, Diesel Generator Set, etc. can be incurred under this component only after the receipt of specific administrative/financial approval from Parishad. List of Machinery & Equipment for various skills is shared with the Principals from time to time. Procedure/guidelines as shared with the field functionaries are to be followed. A copy of letter no. 10/26-2011- ADMN (4) dated 01.08.2011 and Finance Department notification no. 2/1(4)-1/2014 Pt. 87-4FR dated 12/03/2006 is enclosed for ready reference.

6. Office Expenses/Contingencies:-

Expenditure for the following objectives can be incurred under this component:-

- A) Any other expenditure such as publicity of skill introduced, guidance & counselling of students/community mobilisation, stationery, electricity bill, diesel for Gen set, minor renovation of labs, repair of equipment related to CSS-VHSE which is not covered under any other component mentioned above may be incurred from Office expenses component wherein one time amount cannot exceed Rs 2500/- on each item that too subject to availability of funds. The heads of institutions are to ensure that the financial rules are followed strictly while incurring expenditure.
- B) Prior approval of the Parishad is required for incurring any expenditure related to CSS-VHSE under Office expenses on each item under the component if one time amount exceeds Rs 2500/-.

7. Teacher Training:-

Expenditure for the following objectives can be incurred under this component. Since the training of the teachers is organized by SCERT, Gurgaon, no action is required to be taken at school level.

A) Induction Training for Teachers/Skill Trainers- For the training of newly appointed Vocational Teachers, expenditure can be incurred for the following purposes:

C) Honorarium to Resource Persons: In case of a person of Associate/Professor rank if invited from outstation may be allowed journey by AC-2 tier or chair car in Shatabdi Express. For local journey, boarding and lodging inclusive of all, the resource persons may be paid honorarium @ Rs 2,500/- per day. For all other persons who are mostly from SSCs located in New Delhi, may be provided an honorarium, inclusive of all charges @ Rs 2,500/- per day.

Since training is conducted through Director, SCERT Gurgaon, separate administrative/financial approval is issued each time by the Parishad.

Note:- These appended qualifications will not affect the earlier appointed Vocational Teachers by the Department or the Vocational Teachers engaged by the Vocational Trainer Providers(VTPs)- provided they were deployed only after following the procedure as earlier laid down and fulfilled the experience, qualification as prescribed at that point of time.

In view of above details, above Qualifications for deployment of VTs in applied skills will be read with the following foot notes:-

- a. Experience should be from recognized Institute/Govt. Institution, Institutions set up by the corporate houses/companies, authorized dealers in the relevant skills Govt. workshops/workshops of authorized dealers of Manufactures/Production houses. In respect of claim of experience, the candidate will submit the following documents to support the experience certificate document:
 - (i) Appointment Letter.
 - (ii) Bank Statement as proof of receipt of salary in bank account from the employer. Only vouchers for receipt of payment of salary is not acceptable.
 - (iii) Any other documentary proofs which provide documentary proof that the experience certificate submitted is genuine.
- b. Degree/Diploma/Certificates from Institutions/University which are not recognized/certified by UGC/AICTE/State Board/ University/SSC will not be eligible. In case of Certificate/Diploma from a private Institution/Organization it will hold good only if certified by the Sector Skill Council concerned in view of Govt. of India notification dated 17.03.2015 issued by the Ministry of Skill Development & Entrepreneurship.
- c. Experience will be calculated after fulfilling the requisite essential qualifications for any post and should be of full time. Part time experience would not be entertained.
- d. Matric with Hindi/Sanskrit or 10+2/Graduation/Post Graduation with Hindi as one of the subjects.
- e. The age limit between 18-42 years, age relaxation to be provided as per Govt. rules.
- f. As all the subjects are in English medium. Therefore the candidates must have good exposure in verbal and non- verbal communication as it is essential for all Vocational Teachers.

g. Basic knowledge of computer (MS-Office, Internet etc.)
