Subject: Implementation of Online Software for Salary Bills

Your attention is invited to the subject cited above:-

The process of sending the invoices will now be online. You can use the application with the URL i.e **emate.hsspp.in**. User id and password has already been e-mailed to you. You are requested to register in VTP registration form and register your Vocational trainers in VT registration form under **Add employee head**.

In emate software the following steps have to followed:-

- 1. Principal will enter the leaves/absence of teachers in software as also attendance in online software on the last working day of each month.
- 2. After entry of attendance/absence/leave by Principal further automatic bill will be generated and VTP will enter all the deductions in software and release the salary of VTs by  $10^{th}$  of each month.
- 3. After releasing the salary of VTs , VTP will enter the RTGS no. and RTGS date for reimbursement claim online by 15th of each month to Head office. Simultaneously each VTP will generate salary sheet as PDF, sign it and email to the Parishad. He will also record a certificate to the effect that PDF is as per online bill and the salary has been credited to the account of each V.T. through RTGs.
- 4. HSSPP will process the claims for reimbursement and release payment to the VTP within the next 15 days in view of availability of grant from State + Govt. of India

The procedure as well as schedule as mentioned above has to be followed strictly in letter and spirit.
