Dear All VTPs,

This is with reference to the NSQF Project implementation in the Schools allocated to you. All the necessary instructions, guidelines for implementation already stand circulated to you and the funds for the same as per requirement are remitted to schools from time to time. During the monitoring of the project following issues have been observed which require your immediate attention and action.

- 1. As per the guidelines minimum one Guest Lecture is mandatory, whereas in some schools Guest lectures have not been happening despite the fact that one full semester is already over.
- 2. Every quarter an industry visit is mandated. Even this is not happening. The guidelines further say that an approval with regard to checklist of the visit, travel cost, Parents Consent, etc. has to be sought from the Department. This is also not being followed as desired.
- 3. Complied Weekly reports from the teacher duly signed by the school Head has to reach the concerned Coordinator without fail on every Monday. This has been communicated to all concerned but still there are gaps. Compiled reports do not have any observation/feedback from the concerned VTP or many a times reports are delayed.

Request you all to kindly review the project implementation on the points mentioned above and do the needful.
