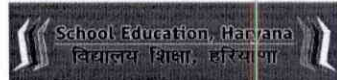

Please refer to my D.O. letter no. 7/9-2014(NVEQF) dated 24.3.14 & 28.3.14 vide which details regarding coverage of 100 additional schools alongwith list were sent to you. These communications also contained instructions in regard to enrolling 25 students in each of the applied skills (2 applied skills per school), organizing guest lecture, opening of Bank account etc. etc.

It was also intimated that the District Coordinators would be shortly visiting each and every school having been allotted these skills from 2014-15 academic session. The objective of such visits was to update/directly assess the admission status in class 9<sup>th</sup>, interaction with the faculty and Head of Institutions, availability of infrastructure etc. etc. so as to consider any changes /modification still required to be made for paving the way for enrolling children(in the respective applied skills finally allotted) in right earnest manner on the reopening of schools on 15<sup>th</sup> April.

The matter was reviewed in a meeting with District Coordinators on 5.4.2014. Based on the feedback/field visits of all these schools by the District Coordinators, certain changes in the list earlier circulated have been approved.

Revised list of additional schools where applied skills (two skills per school) are to be introduced in class 9<sup>th</sup> from academic session 2014-15 in enclosed. This may please be treated as the final list and no further changes will be allowed. Heads of Institution may please be informed accordingly for ensuring that the students in the respective skills are enrolled without any further delay by following proper procedure.

Please acknowledge receipt of this communication and ensure follow up action accordingly.
