3. Background:

Haryana School Shiksha Pariyojna Parishad (HSSPP) is a society registered under Societies Registration Act, 2012 which is primarily responsible to implement Samagra Shiksha in Haryana State. Samagra Shiksha is an integrated Scheme on School Education envisages the 'school' as a continuum from pre-school, primary, upper primary, secondary to Senior Secondary levels. The vision of the Scheme is to ensure inclusive and equitable quality education from pre-school to senior secondary stage in accordance with the Sustainable Development Goal (SDG) for Education.

4. Preamble:

Empowering the girl student to fight back against crime is the aim of this training programme. Even in this modern era, violence against girl students is common. So girl students should practice the techniques of self- defence. Girl students need to learn practical defence techniques in a safe environment from experienced and friendly martial arts instructors under Haryana School Shiksha Pariyojna Parishad, Samagra Shiksha Abhiyan. This practical defence technique program for girl students will be a great way to relieve stress, get and stay in shape, and learn valuable self-defence skills at the sametime.

This program blends a great physical workout with practical real-life self-defence techniques which are beneficial for girl students. Haryana School Shiksha Pariyojna Parishad intends to provide realistic, effective Self Defence Training under Samagra Shiksha Abhiyan for Girl Students of Govt. schools in Haryana State. The girl students will get awareness, prevention, risk reduction, risk avoidance and self-realization of their own physical power through this training. These self-defencetechniques greatly increase personal protection options to combat crime. One can recognize and respond effectively to potentially dangerous situations and by doing this training they will be more confident in their everyday activities. The purpose of the training is to achieve short- term goals of self-protection that reinforce the long-term goal of earning the blackbelt in the field of martial-arts for self-defence.

At this backdrop, the school going girl students are the worst sufferers and they have every chance of being affected. Sometimes, the girls have to travelalone a long way from their homes to reach a Secondary or Higher Secondary School either on foot or by bicycle or by bus. The parents habitually stoop to this apprehension and restraint the girl children to attend schools regularly. Herein lays chances of dropout the girls from their secondary or higher secondary Schools.

Haryana School Shiksha Pariyojna Parishad is keen to outsource theentire Training delivery to eligible organizations/firms in the field of self-defence training programme as partners for the roll out. These partners should be able to provide training instructors to give training in Self- defence in the selected Govt. Schools of Haryana State.



Through this Expression of Interest, HSSPP is intended to shortlist the partners for providing following Self-Defence Training Programme for 3 months under Samagra Shiksha Abhiyan for Girl Students of Govt. schools in Haryana State. The number of schools may vary at the time of finalallocation.

5. Aims & Objectives of the Programme:

- Through self-defence training, girls are taught to make them strong psychologically, intellectually and physically enough to protect themselves in times of distress and vulnerability.
- To equip the girls with self-skills, so that they can avert any kind of awkward situation at the firstinstances.
- To spread a message to the violence-maker that girls are being ready for counterand awareness is being developed among the girls in this regard.
- To empower the girl students in allaspects.
- To improve regular attendance of girl students to the secondary schools.
- To make the Physical Education teacher at each school aware of these skills for the future practice of them as a part of schoolcurriculum.

6. EOI ProcessingFees:

A non-refundable processing fee for Rs. 5,000/- (Five Thousand Rupees only) in theform of a Demand Draft drawn in favour of "State Project Director, HSSPP, Panchkula", payable at Panchkula has to be submitted along with the EOI response. Bids received without or with inadequate EOI processing fees shall be liable to get rejected.

Note: The 'EOI' fees i.e. Rs.5000/- (non-refundable) will be exempted for the agencies/firms/organizations who had applied for last year bid i.e. in the year 2020-21 and had deposited demand draft of Rs.5000/-(Attach Proof), but the tendering process could not be materialized due to Covid-19 pandemic. However, they will have to apply afresh as per requirement of the new financial year i.e. 2021-22.

7. Venue, Deadline & Procedure for Submission of Bid Documents:

a. Proposal, in its complete form in all respects as specified in the EOI, must be submitted to HSSPP at the address specified here in earlier. In exceptional circumstances and at its discretion, HSSPP may extend the deadline for submission of proposals by issuing an amendment to be made available on the HSSPP website, in which case all rights and obligations of HSSPP and the bidders previously subject to the original deadline will thereafter be subject to the deadline as extended.



b. The EOI contain Technical Eligibility Criteria (Part-A) and Financial Proposal (Part-B) both. The EOI documents shall be placed in **two separate envelopes** for technical & financial and must be super scribed respectively as:

(Part-A)"For Technical Eligibility regarding Rani Laxmibai Atma Raksha Prashikshan Programme (Self-Defence) for Girl Students of Govt. schools in Haryana State under SSA"

(Part-B)"For Financial Proposal regarding Rani Laxmibai Atma Raksha Prashikshan Programme (Self-Defence)for Girl Students of Govt. schools in Haryana State under SSA"

c. The **single envelope** containing both the envelopes i.e. Part-A & Part-B documents, must be super scribed as;

8. Validity:

For Bids: Bids shall remain valid and open for acceptance for a period of 3 months (90 days) from the last date of submission of bids.

For Empanelment: Empanelment initially will be valid for only FY 2021-22 i.e. from 1/04/2021 to 31/03/2022 (minimum period of one year), which may be extended further and the supply of the resource will have to be made as per the orders placed from time to time. During the period of work order placed, there shall be no increase in rates.

9. Agreement: - A suitable agreement would have to be entered into with HSSPP, after empanelment and being successful in the financial bid. If the terms and conditions of the agreement are not acceptable to the agency, then HSSPP reserves the right to reject the agency.

10. General Instructions: -

- **a** HSSPP reserves the right to call for further information / documents / break-up etc. to decide on the empanelment.
- **Authorized Signatory:** -The relevant documents, mentioned in EOI can be forwarded by owner or owner's representative. Representative will have to enclose the letter of Authority/ the power of Attorney along with this offer or when demanded by HSSPP, otherwise the offer will be considered null and void at any stage, as per the decision of HSSPP



- **c Right to Rejection:** HSSPP reserves the right to reject all/any applications without assigning any reasons whatsoever at any stage.
- **d. Right to allocation of Work to multiple agencies:** -HSSPP reserves the right to place the orders to more than one agency after the evaluation of Financial Bids. The decision of HSSPP will be final in the distribution of work.
- **e** False Information:- In case, if it is found that the organization/firm has not given the correct information and flouted any condition or the organization/firm does not have all the appropriate licenses and all the statutory permissions whatsoever required, to carry out the activity as required in these assignment then HSSPP reserves the right to cancel the empanelment issued to them and award the assignment in the manner as deemed fit. This can be done at any stage
- **Inspection:** -HSSPP reserves the right to depute its officers, Auditors, other officials as it may decide etc. to visit the office/commercial/ of the selected/empanelled agency for checking their infrastructure, manpower and other related documents mentioned and for checking records, quality controls, work processes without advance intimation and the agency will have to provide the necessary documents etc. to HSSPP.
- **g** Confidentiality: The empanelled agency after appointment shall maintain strict confidentiality of all the documents, information, any oral, written or other information for any other purposes shall be considered as confidential information passed to the agency byHSSPP.
- **h** This Expression of Interest is for Empanelment of the agencies and does not guarantee placing of empanelment. In Normal Circumstances, the order would be awarded to the lowest quote among the empanelled agencies through invitations of the financial bid, as per the requirement of the HSSPP.
- i In appropriate cases, HSSPP reserves the right to reject even the lowest quote. HSSPP is at liberty to disqualify the empanelled Agency even after once empanelled if it is found subsequently that the quality of service is not up to the mark as per the terms, conditions and requirements laid down/informed to the agency at the time of executions. If it is found that some concealment/non-disclosure of material facts made by the agency in order to qualify, HSSPP reserves the right to disqualify party and also realize the expenses / loss incurred by HSSPP.
- **Breach of Clause:**-In the event of any breach or threatened breach of any clause by the Agency and/or individual assigned by the Agency for the performance of the services, the agency shall be liable to pay damages as may be qualified by HSSPP. Apart from the above, HSSPP shall have the right to proceed against the agency and /or its assigned person/s under appropriate law.
- **k Termination:-**HSSPP reserves the right not to empanel any or all applications without assigning any reasons as also to terminate the contract at any stage without assigning anyreason.



- **Blacklisting:** -The Training agency merely by filling the empanelment form confirms that their firm has not been blacklisted / debarred by any government department/ Organization, Reserve Bank of India, Nationalized bank, or any Public Sector unit or body. The firm is advised not to apply for the said empanelment, if they have been disqualified by any of the government organization.
- **m Jurisdiction:** All matters pertaining to this empanelment shall be subject to the jurisdiction of the courts in Panchkula and Chandigarh only.
- **Taxes & Other Related Liabilities:** The financial proposal should be inclusive of all applicable taxes, cess and any other outgoing payable to any authority. The ESIC, Employee Provident Fund, GST, if applicable would be on account of the organization. TDS as applicable will be deducted by HSSPP.

- Age 18 years or above.
- Well versed with at least one of above mentioned skillsof Martial Arts for Self-Defence.
- Good physical and mental health.
- Should not be addicted to drugs, alcohol and smoking etc.
- Good moral conduct and there should not be any criminal case/ sexual harassment case against the master trainer.

Note: Master trainer should not be employee of Haryana School Education Department and HSSPP.

- a. The applications, being invited through this EOI are meant only for empanelment of service provider agencies/firms and not for final work agreement. The technical & financial bid shall be opened on the stipulated date by the committee authorized by the competent authority of O/o HSSPP. The date fixed for opening of bids, if subsequently declared as holiday by the Government, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working date, time remaining unaltered.
- b. **Part-A:** The suitability of organizations will be ascertained and if found suitable they would be empanelled based on the eligibility criteria mentioned under clause 13 Part-A and scope of work mentioned under clause 11 (a) & (b).
- c. **Part-B:** The financial proposals will be opened only for technically eligible/qualified agencies. Further, after evaluation of the financial proposals and on discovering of lowest rate (L-1), the agencies/ firms quoting L-2, L-3 & L-4 (max up to L-4) may be offered to match L-1 rates by taking their written willingness and request for work allocation.
