Applications are invited through email to be send on iedsshry@gmail.com (Send the filled form after scanning along with scanned qualification certificates and scanned experience certificates on above mentioned email id) for engaging one Consultant on contract basis initially for a period of 3 months with a negotiable package including T.A. to get the surgeries conducted in collaboration with HSSPP and National Health Mission (NHM) for about 1150 Divyang students who have been identified during the Medical Assessment Camps conducted from time to time under Inclusive Education for Disabled (IED) under Samagra Shiksha. These surgeries are required to be conducted by Consultant in a mission mode through Govt. empanelled hospital by negotiating between NHM and District Project Coordinators (DPCs) of the district concerned for quick disposal of these surgeries with following conditions:

- The Consultant so engaged can be removed during the contract period provided his work & conduct is not found satisfactory without giving any notice.
- The maximum age limit of the Consultant should be 65 years.
- The Consultant will be governed as per the condition of their existing contract agreement.

The detail of qualifications, experience and work to be done by the Consultant is submitted as under:

## **Essential Qualification/Requirements-**

The person so engaged should be postgraduate.

Person should have worked in Govt./Semi Govt./ PSU organizations in senior capacity and should have managed and worked with the medical assessment camps specifically for physically challenged/ senior citizens. He should have associated

with the Govt. schemes, should have participated for upliftment of poor and physically challenged.

The following works are to be carried out by the Consultant:

- Consultant will be in close coordination with the District Project Coordinators, Assistant Project Coordinators working under Education Department and District Early Intervention Centre (DEIC) Manager of the concerned district working under National Health Mission (NHM) regarding corrective surgery of divyang students.
- Consultant will prepare a list of divyang students according to their disabilities covered in a particular type of surgery and will identify the Govt. empanelled private hospitals in the district concerned, where surgery of divyang students is to be conducted.
- Consultant will get the corrective surgery of divyang students in that particular hospitals in collaboration with DEIC Manager and APC of the district concerned.
- Consultant will submit the estimated amount of surgery of a particular student for surgery to the HQ for obtaining the approval.
- Consultant will manage to make the payment to that hospitals through DPCs out of the funds already provided to them.
- Consultant will submit the progress of the surgeries made fortnightly to the HQ.
- Consultant will coordinate with the parents and district authorities with regard to the indoor surgeries as well as outdoor follow up of the activities.
- Consultant will manage to provide the utilization certificate for the amount spent by him through DPCs.
