Sir/Madam,


Government have reviewed the matter regarding grant of extension to the Vocational Teachers deployed through VTPs for the implementation of Centrally Sponsored Scheme of Vocationalization of secondary & higher secondary Education.

While doing so, the Government has considered the representations from Vocational Teachers, VTPs as also the fact that these are predominantly practical based skills with the sole objective of enhancing employability potentional of students. Therefore professional competency of the teachers, their performance are the basic parameters to be kept in view.

In the given background the clarifications as listed below are hereby communicated for immediate follow up action/ compliance for extending the contract of Vocational Teachers for 1 year beyond 31.03.2017:-

- The experience of Vocational teachers for the purpose of deployment be counted after his/her acquiring essential professional qualifications so prescribed and not the academic one.
- Vocational Teacher deployed with having acquired prescribed professional certificate/ diploma in the relevant skill from private institutions/ organisations will get it certified within one year from Sector Skill Councils as per Government of India notification.
- MSC. (Computer Science) / IT are also to be considered eligible for deployment of IT/ITes Teachers.
- In case of Vocational teachers, in Retail, Banking & Finance, Banking & Insurance, the MBAs having studied the relevant subject in MBA are also to be considered.
