i) The objective type will be of 100 marks, consist of General Knowledge, Mental Ability (Reasoning & Quantitative Technique), Child Development and



Psychology, Hindi and English (Matric level) and duration of the paper will be 2 hours.

- ii) Minimum scores of 45% for SC/PH and 50% marks for others in aggregate in accordance is required for selection.
- Professional Training Diploma or Certificate awarded by any State, Board of University other than Haryana Education Department must be recognized by the Haryana Government. The candidate is required to submit the Equivalency Certificate at the time of documents verification.
